

The carrier-class, 802.11a-based, 5 GHz radio module (model: XR5) is specifically designed for mesh, bridging, and infrastructure applications requiring the highest levels of performance and realiability. The transmitter must only be used with the approved antenna(s). Please refer to www.ubnt.com/products for details The XR5 is only capable of 5745-5850 MHz frequency range

per the FCC/IC grant. Power and frequency limits are hardcoded into the radio card FFPROM It is necessary that the system

integrators perform all applicable retesting and certification for their final system configurations.
