



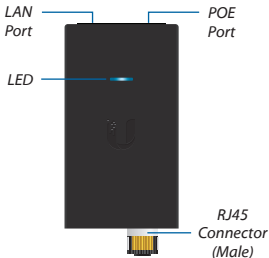

Installation



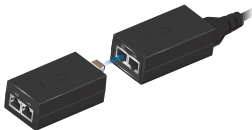
WARNING: Do not connect non-PoE devices (such as laptops) to the *POE* port.

To install the airGateway, perform the following steps:

1. Disconnect the Ethernet cables from the Ethernet ports on the PoE Adapter that is connected to your airMAX device. Ensure that you note which cable was connected to the *POE* port and which cable was connected to the *LAN* port.



2. Connect the male *RJ45 Connector* of the airGateway to the Ethernet port labeled **POE** on the PoE Adapter.



3. Connect the Ethernet cable that was disconnected from the *POE* port in step 1 to the Ethernet port labeled **POE** on the airGateway.



4. Connect the Ethernet cable that was disconnected from the *LAN* port in step 1 to the Ethernet port labeled **LAN** on the airGateway.



Connecting via Wi-Fi

To configure the airGateway, you must access it via Wi-Fi from a host machine.

1. Connect your host machine Wi-Fi to the wireless network (SSID) named **www.ubnt.com**

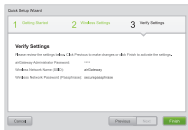

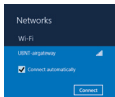

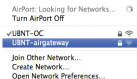
